


## **Your Linacre Legacy**

# An Opportunity to Make a Difference Beyond Your Lifetime

Linacre is a place of academic excellence where graduates excel in a supportive and welcoming community and world-leading research happens every day. We are committed to providing opportunities for talented students from across the globe, regardless of their background or financial circumstances. Leaving a legacy, bequest or planned gift to the College in your Will is one of the most meaningful ways to help our community grow, develop, and thrive.

Though we manage our finances soundly, Linacre has one of the smallest endowments of any Oxford college. With rising costs and fewer funding opportunities, we must strengthen our long-term financial position by increasing the endowment and we are committed to expanding the provision of scholarships, hardship funds, research support, and improving facilities. Legacies have played a central role in the development of Linacre and the lives of its people. From funding library renovations to providing scholarships, legacy gifts help us continue to transform lives and champion graduate learning for future generations.

## **Your Linacre Legacy**

A gift in your Will of any size or type will have a lasting impact here at Linacre. We welcome all types of legacy gifts, and a bequest can be arranged in several ways. A legacy gift can be written into a new Will, or added to an existing one using a Codicil form. We always advise speaking to a legal adviser before drafting a new Will, updating an existing one or making other plans for your estate, so that your Will meets your needs, supports your family and loved ones, and takes advantage of any tax benefits.

There are currently several methods by which you can remember Linacre in your Will:

#### Residuary legacy

This is the gift of all or a percentage of the net residue of your estate, after all gifts to family and friends, liabilities, legacies, and administrative expenses have been met. This form of gift is particularly simple as you do not have to quantify the sum or worry about inflation when you draw up your Will.

#### **Pecuniary legacy**

This simple form of legacy allows you to give a specific sum of money to Linacre. To safeguard its value from inflation, your Will can provide for it to be index-linked.

#### **Specific legacy**

This is the gift of something valuable like a property, a piece of jewellery or stocks and shares, either to be used or to be sold to generate funds.

#### Reversionary legacy

This gift has the advantage of providing for your family first and then benefiting the College. So when the original beneficiary dies, the gift in your Will reverts to Linacre College. Your solicitor or legal advisor will be able to provide you with wording for this form of legacy.



When arranging a gift in your Will to Linacre, your solicitor or attorney will need to advise you. Here is some example wording:

I give [detail the proportion of your estate, fixed sum or specific asset] to The Principal and Fellows of Linacre College, Oxford (UK Registered Charity No. 1142130) with the request that it be used for its general charitable purposes.

I declare that the receipt of the Bursar or other duly authorised officer of the time being of the said College shall be a full and sufficient discharge to my Executors or Trustees for the discharge of the said legacy.



### **Tax Benefits**

Including Linacre in your Will is a straightforward and fulfilling gift to make and, depending upon where you live in the world, there can be a number of financial advantages.

## **Sharing Your Intentions**

The College is also happy to explore any particular priorities you wish to support and receive legacy gifts directed to a specific purpose, such as scholarships, research, facilities, and the College endowment.

Any information given will be treated confidentially and is non-binding.
